




All Unique RWPA Clients by Race/Ethnicity, CY2016 (N=2,805)




Percent of RWPA Clients by Service Category, CY2016 (N=2,805)




All Unique RWPA Clients by Age, CY2016 (N=2,805)




All Unique RWPA Clients by Gender, CY2016 (N=2,805)




All Unique RWPA Clients by HIV Risk Factor, CY2016 (N=2,805)






Gender of Persons Living with HIV in Clark County, 2015 (N=8,753) vs. RWPA Clients, (n=2,805)




Race/Ethnicity of Persons Living with HIV in Clark County, 2015 (N=8,753) vs. RWPA Clients, (n=2,805)

HIV Risk Factor for Persons Living with HIV in Clark County, 2015 (N=8,753) vs. RWPA Clients, (n=2,805)


